Minister opens Castlehill's NEW Countesswells homes



Housing Minister Kevin Stewart has officially opened a flagship development for Castlehill Housing Association in Aberdeen

The first tenants have now moved into both Castlehill Housing Association and Osprey properties at Countesswells, built by Stewart Milne Homes on the western outskirts of the city. This is the first planned new community for Aberdeen and the only housing development in the UK supported by HM Treasury's UK Guarantee Scheme, along with £7.3 million of funding from the Scottish Government for 106 units.

Castlehill Housing Association Chief Executive David Lappin said:

"We are delighted with the handover of these much needed new properties. This is a landmark for Castlehill Housing Association that brings our stock in the North East to over 2,000 homes."

Mr Stewart toured the site and met some of the new tenants. He said:

"I am delighted to see the completion of the first phase of affordable housing at Countesswells, which will bring great benefits to the area. It not only provides high quality, affordable accommodation, but an exceptional place to live.



"Support for this development is a great example of how the Scottish Government is helping provide the right homes, in the right places, and to a standard anyone would be proud to call home – a core part of our drive to make Scotland a fairer and more prosperous country.

"We are committed to delivering at least 50,000 affordable homes over this Parliament – backed by £3 billion of investment. As this projects shows - with a promise of 106 affordable, energy efficient homes on this particular development – I am confident that target can be achieved."

Castlehill has a mix of one, two and three-bed flats and houses at the development, providing a mix of social and mid-market rental (MMR) properties. Castlehill's remaining 12 MMR units will be handed over by the end of November, with the final nine social rented units handed over by mid January.

Countesswells, which will have 3,000 new homes, including 750 affordable, will be phased in over 15 years, boosting the local economy and supporting 1,000 construction jobs in the region. Facilities within Countesswells will include a new secondary school and two primary schools, healthcare facilities, local business units, retail and leisure, together with high quality open, civic spaces and extensive parkland linking the community to the existing mature woodland.

CaRTO Secretary's Report 2017



It has now been a year since the Tenants Panel made the decision to become a Registered Tenants Organisation (or RTO). The Tenants Panel had developed over a few years and grown in numbers, and the time was right to progress and take the organisation to the next level, being officially recognised by the Scottish Government. We devised a constitution and set out our aims and objectives. We chose a new name - Castlehill Registered Tenants Organisation, a.k.a CaRTO.

Our main purpose is to encourage the tenants and residents of Castlehill to engage with each other and Castlehill, and to discuss policies and issues affecting all tenants.

The benefits to being a Registered Tenants **Organisation include:**

- A right to be consulted over proposed changes to housing services.
- The opportunity of applying for grant funding from the Scottish Housing Regulator.
- The opportunity to get involved in regional RTO networking forums.

In the year since CaRTO has been established, tenants have made many achievements and been involved in many different projects and meaningful activities.

- Three CaRTO members now serve on Castlehill's Management Committee
- CaRTO's Secretary was shortlisted as one of 4 finalists for the Tenants Information Service National Excellence Awards, recognising his voluntary work with Castlehill, with NETRALT, with social housing at a regional level and also his voluntary work outside of social housing with the wider community.

- CaRTO have been integral in designing the new Castlehill corporate website
- Brought our tenants closer together by focussing on our Moray tenants and making it easier for them to be a part of CaRTO
- Moray tenants being involved in the development of Moray Tenants Partnership, which has now changed its name to Northern Tenants Partnership as it has grown to incorporate a wider area
- Developing a new design for Castlehill's Annual Charter Performance Report
- Discussing the results of the three yearly tenant satisfaction survey and how CaRTO and Castlehill can work together to achieve better outcomes in certain areas
- Fire Safety consultation
- Tenants have been consulted on the Freedom of Information Act
- Tenants attended a "Value for Money" seminars
- Study trip to Blackwood's flagship assisted living development in Dundee
- Visit to the Scottish Parliament
- CaRTO tenants continue to play a significant part in NETRALT (North East Tenants, Residents and Landlords Together) and in fact make up a third of active members.
- Two tenants went to the annual TPAS conference (TPAS stands for Tenant Participation Advisory Service), which is the leading conference aimed at tenants to educate inform and inspire on all things tenant participation.
- CaRTO asked that the annual sheltered magazine be reinstated and this is now happening, with a new look magazine to be published in April.
- CaRTO have input as to what they would like to see included in The Chain newsletter
- A major achievement was CaRTO devising a devolved budget proposal that has been accepted by Castlehill.

Going forward, we have lots of ideas and plans we are excited to be working with Castlehill on, including supporting tenants with digital participation, encouraging local groups and helping shape a better housing service for tenants.

Community garden taking shape with (S) foyer **Reach**



You may remember from the last edition that a group of tenant volunteers have been gradually transforming a disused area of ground at Aquhorthies Circle in Inverurie (off Blackhall Road) with the vision of creating a community garden. They were joined recently by members of Inverurie Foyer Reach Team 8, who have helped them in their quest to create a peaceful place to enjoy nature and to garden collectively as a community.

Foyer Reach is a 12 week employability course for people in recovery from anything that has held them back from progressing towards employment, training or further education. Foyer Reach operates in partnership with Aberdeenshire Council, Aberdeenshire Alcohol and Drug Partnership and North East Scotland College.

which is where helping to improve the community garden at Aguhorthies Circle came in. The team had to raise their funds so they held a coffee morning and raised £140 for the project, which helped pay for a new bench and materials. They consulted and worked with volunteer tenants to share ideas and help shape the community garden.



All the tasks that the team took part in for the fundraiser and community project gave them confidence and skills that they can develop which increases their employability skills, and up to date experiences that they can highlight in application forms and interviews.

The team was led by Claire Farguharson, Development Coach for REACH. Over the years, Claire has led many courses and she said, "It's interesting to see how much the students have learned and have gained in confidence in such a short space of time."

Diane Edwards, a Castlehill tenant said, "The garden has had a huge boost due to the help of the group. There are two compost bins, the start of a mud kitchen, a bench, flowers and a huge area has been cleared for vegetables and fruit plus so much more. The council helped, some tree surgeons came and cleared an area and also I & K Motors donated tyres. It was amazing how much could get done in such a short time. If anyone has any ideas and would like to take part even just for a small amount of time then that's great. Any help is much appreciated as are any donations."

Supporting Scotland's Older Veterans

Have you ever served, or are close to someone who has? Help could be available and it's easier than you may think, for those who have been involved with the Territorial Army, Royal Navy, Royal Air Force, National Service, Merchant Navy. If you are not sure, please ask (contact details are at the end of this article).

Unforgotten Forces is a collaboration of 15 organisations, large and small, all of whom have made a commitment to work together and individually to develop new services and improve existing access to services for veterans and their families.

This Government-funded project arises out of a need to address isolation and marginalisation in the community and thereby improving overall wellbeing. At the moment the service is being aimed at 'older veterans' (roughly 60 and above) but we hope to secure further funds which will enable us to roll the service out next year across all age groups.

Unforgotten Forces partners include:

Action on Hearing Loss

Our service will provide support to veterans, their families and/ or carers on issues surrounding their hearing loss or tinnitus and offer a pathway of support alleviating concerns over their hearing loss.

Age Scotland

Information, friendship and advice through the Age Scotland helpline 0800 12 44 222: including care, benefits, housing, legal issues, veterans' rights and services. Community development – training member groups on veterans' rights and issues, linking to opportunities, digital inclusion policy and influencing – using evidence from service delivery to inform policy developments.

Armed Services Advice Project (CAB ASAP)

Advising Older Veterans: The Armed Services Advice Project (ASAP), part of the Scottish Citizens Advice Bureau Service, will provide information, advice and support to older veterans. We work with organisations supporting older people, reaching out to older veterans, and work with other organisations to help people access the support they need.

Defence Medical Welfare Service (DWWS)

DMWS will deliver a holistic medical welfare service, providing emotional and practical support for veterans, their families and carers, in health care pathways. Working with partners, we will enable early supported referrals to appropriate local support and services thereby improving recovery, wellbeing, discharge planning, independent living, and reducing social isolation.



Fares 4 Free

Fares4Free is a charity (SCIO) that coordinates and provides free transport by asking taxi drivers to give up to 4 fares per month to help us help Veterans access important services and combat loneliness and isolation. Our aim is to fight loneliness and isolation one mile at a time.

ILM Highland

The Highland Veterans Handyperson Service is a partnership with Unforgotten Forces, Care & Repair Scotland and ILM (Highland). Together we will help veterans over the age of 65 who are having difficulties with carrying out small jobs around the house in Moray.

Legion Scotland

Legion Scotland's community support and comradeship services will help veterans to combat loneliness and isolation by engaging with the community through tailored activities and support visits. The focus of comradeship events is to get veterans to mix with fellow veterans.



Music in Hospitals & Care

Music in Hospitals & Care's project Play it Again SAV will enable older veterans to design musical programmes full of their own personal choices. Professional musicians will work with people living in designated care homes for retired service personnel to co-produce playlists which will ultimately be played live for them and for other audiences in the future.

Poppyscotland

Poppyscotland provides life-changing support to our Armed Forces community, reaching out to those who have served, those still serving, and their families at times of crisis and need by offering practical advice, assistance and funding. The Break Away service will provide respite holiday coach tours and hotel breaks across the UK for older veterans and their families.

Scottish War Blinded

SWB supports veterans with a visual impairment that impacts on their independence. The sight loss does need not be a result of their service. SWB works throughout Scotland and provides specialist equipment and training to maintain independence, financial and practical help to improve quality of life and social opportunities.

Scottish Older People's Assembly (SOPA)

Scam Warning: Phone message threatens HMRC lawsuit

HMRC (Her Majesty's Revenue and Customs) has warned of a scam which targets taxpayers and seems to be aimed at older people in particular. We have been asked to share the following information:

There is currently a telephone scam where a recorded message is left, allegedly from HMRC, stating that HMRC are bringing a lawsuit against the individual and is going to sue them. The recipient is asked to phone 0161 850 8494 and press "1" to speak to the officer dealing with the case. This scam is becoming widely reported and seems to be targeting older people.

Please do not reply to the message.

HMRC takes security very seriously but you need to be alert. If you cannot verify the identity of the person making the call you should not disclose your personal details. You should report these incidents on the Action Fraud website, or you can call them on 0300 123 2040 (Please note this number will be charged at your normal network rate). They are open Monday to Friday 09:00 - 18:00.

could take away the stress of trying to organise and cope with what could be a difficult time for the person with dementia.

Small changes to the home environment like these have been shown to reduce falls, accidents and confusion. This can lead to an increase in confidence and independence, and even better physical health. Early intervention could also be less costly in the lona run.

Many of the specific changes needed are preventative in nature and are enabling or re-enabling, and while these physical changes in the home need not be dramatic, often the improvements in well-being and confidence for a person with dementia can be significant.

What is the Private Residential Tenancy I keep hearing about?

Please note that this agreement DOES NOT apply to Castlehill Housing Association tenants because we are a registered social landlord, not a private landlord. However, if you are considering a move to private rented property, then it is important that you are aware of these changes. Castlehill subsidiary, Castlehill Solutions, has private tenancies available for mid-market rent.

The Private Housing (Tenancies) (Scotland) Act 2016

Its purpose is to improve security for tenants and provide safeguards for landlords, lenders and investors. The tenancy will be open-ended and will last until you wish to leave the let property or your landlord uses one (or more) of 18 grounds for eviction.

Improvements for tenants include:

- more security it's an open-ended tenancy so your landlord can't just ask you to leave because you've been in the property for a set length of time
- protection from frequent rent increases your rent can't go up more than once a year and you must get at least three months' notice of any increase
- any rent increase can be referred to a rent officer, who can decide if they're fair



Please ensure that you have money in your account to allow your rent to be paid on 3rd January 2018.

- if you've lived in a property for more than six months, landlords have to give 84 days' notice to leave (unless it's because you've done something wrong)
- if you think you were misled into moving out, you can now apply to the First-tier Tribunal for a 'wrongful termination order'. If the Tribunal gives the order it can award up to six months' rent in compensation
- local authorities can apply to Scottish Ministers to cap the levels of rent increases in areas where rents are rising too much

- It is well known that drug dealers from Liverpool, Birmingham, Sheffield and London are targeting vulnerable members of our community and taking over their homes to store and deal heroin and cocaine.
- This behaviour is known as 'cuckooing' and is extremely harmful to individuals and our community.
- Housing Officers are liaising with Police Scotland to combat the issue and are urging tenants to report any suspicious behaviour including:
- Increased visitors throughout the day / night
- Increased vehicles outside the address, including taxis, new vehicles and hire cars
- Increased anti-social behaviour in the area
- Occupant staying elsewhere or appearing withdrawn
- The smell of cannabis

If you have information about potential drug dealing where you live, contact your local community policing team on 101 or your housing officer and this can be done confidentially.

You can also give information anonymously to the independent charity Crimestoppers - 0800 555 111.

Fairy Lights & Decorations

- Unplug fairy lights or other electrical Christmas decorations when you leave the house or go to bed.
- Check fairy lights are in good working order and replace any bulbs that have blown.
- Bulbs can get very hot; don't let them touch materials that can scorch or burn easily, such as paper or fabrics.
- Make sure the **fuse in the plug** is the correct rating.
- If you need to plug more than one appliance into an electrical socket use a multi-socket adaptor which is fitted with a fuse and has surge protection.
